An important update for resident family members on February 13, 2024.

We currently have no COVID-positive residents in the Residential Health Care Facility, this is excellent news!

All floors are open for visitation; however, we continue to have COVID in the community. We still recommend that visitors wear a mask to protect our residents when visiting loved ones. Masks are available on every floor where you check in and in the hospital lobby. Please also utilize the hand sanitizer available outside the resident's room to sanitize hands before and after visiting.

We will continue to post any infection control precautions and related news pertaining to your loved one's floor on the easel where you check in on each floor. Be sure to check for any updates each time you visit, and if you are not feeling well, please consider postponing your visit.

An important update for resident family members on February 6, 2024.

All floors remain open for visitation; however, we continue to have COVID positive residents on each floor of the Residential Health Care Facility except third floor. With COVID positive residents on the first, second and fourth floors, you may want to consider postponing your visit to these floors. If you choose to visit, please be aware that you are at higher risk of exposure to COVID.

It is highly recommended that visitors wear a mask while visiting these floors at the RHCF. Masks are available on every floor where you check in, and in the hospital lobby. We also ask that you limit your visit to the resident's room that you are visiting. Please utilize the hand sanitizer that is available outside the resident's room to sanitize hands before and after visiting.

We will continue to post any infection control precautions and related news pertaining to your loved-one's floor, on the easel where you check-in on their floor. Be sure to check for any updates each time you visit, and if you are not feeling well, please consider postponing your visit.
