Key Financial Statistics:

He noted this represents direct operational support for the Lewis County Hospice program in 2022. Mr. Cayer added that over the last five and half years the Friends of Lewis County Hospice have donated \$625,000 to ensure continued access to care for the hospice patients and their families in Lewis County.
